

## **GOVERNING BODY**

### **Functions and Responsibilities:**

1. To administer and monitor the teaching in the college and to determine the teaching requirement of the Institute.
2. To monitor and evaluate the teaching programmes in the college and suggest remedial measures, with the guidance and assistance of an Advisory Committee to be constituted for each programme comprising of three professional in the field. The Advisory Committee to be constituted by the Governing Body will be submitting a technical inspection report every six months on the standards of teaching and the progress of studies in the college
3. To appoint the Principal / Director, teaching and non-teaching staff on the recommendations of the Selection Committees constituted under the regulations of the University.
4. To recommend regarding the reduction/ increase of intake and programmes

5. To monitor faculty deployment and development, placement and industry-institute interaction activities in the institute/college and suggest remedial measures wherever necessary.
6. To perform such other duties and exercises as may be entrusted by the management and the University.
7. To ensure the establishment and monitoring of proper, effective and efficient systems of control and accountability
8. To monitor institutional performance and quality assurance arrangements
9. To promote of transparency and openness at every level

The Governing Body approves the college annual budget, health and strategic directions etc. Institution has a governing body in place wherein the members are drawn from distinguished cross-sections of the society.
