3. This Court vide order dated 22.08.2022 passed the following *interim* order in I.A. No.1 of 2022 in W.P. No.32677 of 2022 & batch.

"28. In view of the above discussion, these petitions are allowed as follows:-

i) The 1<sup>st</sup> respondent shall permit the petitioners institution to collect fee as agreed by the petitioners during the personal

hearing from the students for the block period of 2022-23 to 2024-25 as mentioned in the above table. However, such collection of fee from the students by virtue of this interim order is subject to fixation of fee by 2<sup>nd</sup> respondent to be notified by 1<sup>st</sup> respondent.

- ii) The aforesaid interim arrangement is subject to the result of the present writ petitions.
- iii) The petitioner Institutions shall indicate about the pendency of the present writ petitions and also granting of the interim order to the students to enable them to exercise their option.
- iv) The petitioner institutions shall keep the said difference amount in their accounts and shall submit an undertaking to 1<sup>st</sup> respondent to the said effect.
- v) Liberty is also granted to the petitioner institutions to take steps to challenge the report dated 01.08.2022 said to have been submitted by 2<sup>nd</sup> respondent to 1<sup>st</sup> respondent and also notification to be issued by 1<sup>st</sup> respondent, if so advised.
- vi) If the petitioner institutions failed to succeed in the present writ petitions and also in the writ petitions to be filed if any, by the petitioners challenging the decision/ recommendation of 2<sup>nd</sup> respondent fixing the fee notified by 1<sup>st</sup> respondent, or if the same is less than the amount agreed by them, the petitioners Institution shall refund the said excess amount collected, to the students with proper acknowledgment and report the same to this Court by way of an affidavit."
- 4. The petitioners herein are also standing on the very same footing and they are entitled for the said *interim* order dated

22.08.2022 to maintain parity. Accordingly, the order dated 22.08.2022 passed by this Court in I.A. No.1 of 2022 in W.P. No.32677 of 2022 and batch is also granted in this batch of writ petitions.
