Reddy (Dist), Hyderabad, 500088 (hereinafter referred to as "the Institute").

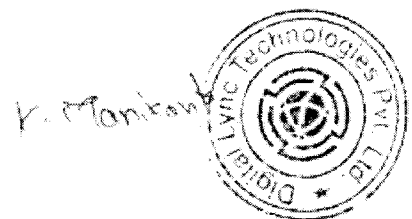

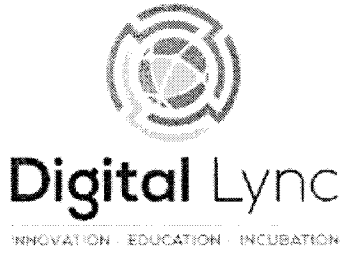

- The purpose of this M.O.U is with reference to exploring the areas of cooperation, benefiting both **the Institute** and **the Industry**.





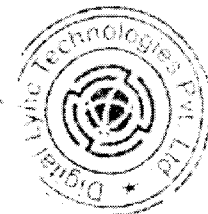

8. Neither this M.O.U., nor any activities described herein, shall be construed as creating a partnership, joint venture, agency or other such relationship. Both parties agree that this M.O.U. represents a nonexclusive relationship between the parties and nothing contained herein shall preclude either party from participating/initiating similar relationship with third parties.
9. This M.O.U may not be amended without the prior written consent of both the parties.
10. This M.O.U. will be effective for five years from 25-01-2016. This Agreement can be renewed based on mutual convenience.
11. **Termination:** Either party can cancel or terminate this Agreement unilaterally (and without reason), by giving an advance written notice of one month to the other.
12. **Indemnity:** Each of the parties shall defend, indemnify and hold the other party harmless from and against any claim, liability, loss, costs or expenses (including reasonable Attorney's fees) arising out of or resulting from the material breach of the provisions herein.
