### **Anti-Ragging Committee**

#### **Caution Measures and Instructions**

Anti-Ragging Committee of NNRG works on the policies based on honorable Supreme Court of India & UGC Regulations on curbing the menace of ragging in higher education institutions.

- 1. Details of every student taken in writing to extend the safety provision to the maximum extent.
- 2. Anti Ragging Committee (ARC) is constituted before the commencement of 1st Year Classes.
- 3. In addition to ARC, Anti Ragging Squad is constituted to intensify safety measures.
- 4. Senior students are addressed and alerted by head of the Institution about the consequences of ragging (if attempted).
- 5. Parents and I-Year students (Freshers) are briefed on the day of orientation.
- 6. Separate lunch time for First Year students is scheduled to avoid any problematic situation.
- 7. Squad will observe in the common areas such as Cafeteria, Ground and beyond the campus (Narapally).
- 8. Mobile numbers of HoDs / Class Incharges / Anti Ragging Committee members are well displayed and list is available in the website (<a href="www.nnrg.edu.in">www.nnrg.edu.in</a>)
- 9. Display boards, sign boards, posters are displayed for the awareness.
- 10. Inspector of Police addresses the senior students about Ragging/punishment/ consequences/ importance of anti ragging campus.
- 11. Regular meetings are conducted with staff and students about the Anti Ragging measures.
- 12. Separate seats (front rows) in buses are allotted to I-Year students.
- 13. Formal interaction among first year &second year students is arranged in the presence of institute authorities.
- 14. The co-curricular & cultural activities with the joint participation of seniors and juniors are held periodically in the guidance of faculty.
- 15. Squads accompany the First year students after the college hours up to Main gate of NNRG/Narapally.

In our institute if any student is found indulging in any activity which comes in the category of ragging, then he/she becomes liable to any or all of the following punishments:

- Suspension or expulsion from the hostel or the institute.
- Debarring from representation in events
- Withholding of results
- Anything which the ARC committee finds suitable based on enquiry and facts.

# ANTI RAGGING COMMITTEE REPORT FOR 2022-2023

The Anti Ragging committee of NNRESGI has taken proper measures to prohibit the ragging in the campus for the academic year 2022-2023. All the students are informed to follow the campus rules and code of conduct framed by Anti ragging committee and Anti Ragging Squad before the commencement of I B.Tech / B.Pharmacy / MBA.

- In all prominent places in the campus Caution boards of Ragging and its bad consequences and severe action taken against this are displayed on the boards.
- Anti ragging display boards and banners containing the evils of ragging and the administrative actions in the event of ragging are displayed around the campus to enable student community to actively engage themselves in hands-on learning and thereby develop their knowledge and skill so as the attain a prominent position in the society.
- The Director of the Institution frequently organized meetings with the convener and members of the committee on how to make students aware about the worst affects of ragging on their lives.
- The convener anti ragging committee of the institution along with the members addressed the senior students about the consequences of ragging by visiting all the classes.
- As a regular practice the Circle Inspector of local police station was invited to address the senior students.
- > To prevent ragging issues like every year the institute has made separate lunch break timings for fresher's and seniors.
- The Physical Director of the institute and few committee members monitor frequently all the common places of the institute to avoid ragging in the campus.
- All the students and parents were given undertaking forms that they will not involve in ragging during their admission. The students as well as their parents have submitted the hard copy of the undertaking forms.
- The Transport in charge of the institute is advised to allocate front (first) seats to I year students, the middle places to faculty and the last seats to senior students to avoid unnecessary disputes among the students.
- The institute plan and organized fresher's day programme within one month after students join the campus, where seniors and juniors come together, mingle with each other and to build amicable relationship between students.
- > The campus is under CC TV surveillance in the common areas and the areas prone for ragging activity.
- > The institute takes all the measures to prohibit ragging and made campus as ragging free campus.

The meeting of Anti Ragging Committee has been convened on 24.08.2023 at 2.30 PM in the Conference Hall in Ground Floor with all the Deans, HoDs and members of Anti Ragging Committee.

The Convener, Anti Ragging Committee welcomed all the Anti Ragging Committee members for the meeting and requested the Director to address the gathering.

The Director said that the Anti Ragging Committee Meeting is being organized to discuss steps to be taken to bring confidence to students and parents. The Anti Ragging Committee was constituted to look after the protection of junior students from senior students regarding ragging inside or outside the campus. The Director said that there are no ragging cases in our campus from the inception and our campus has been a ragging free zone. We achieved it with the cooperation of all the Deans, HoDs, Faculty, Staff to the HoD, H&S and Convener, ARC. Though we may not anticipate any cases, the anti Ragging Committee has to observe the movements of senior and junior students within the campus and outside the campus. The senior students will try to interact with 1st year students and interaction is not ragging, but it should not cross the limits. The GOI, UGC, JNTUH, AICTE, TSCHE etc. and all other constituent bodies kept Toll free number in public domain. If any student give complaint, immediately passes the information to the Director General of Police and Local Police of that area. Even though there are no cases inside or outside, we should be very vigilant. Though there are no cases of ragging, but there may be some apprehensions in students and their parents since they are very sensitive. So we have to create confidence in students and their parents. Once the child admitted in the Institution no activity of ragging and no further disturbances should be prevailed in the campus. The procedures to be followed will be explained during the Orientation / Induction programme to create awareness The students common meeting points like Canteen, in the students and in the parents. Library, Buses, outside bus stops and nearby shops, outside the campus also to be monitored by Anti Ragging squad. We have to take care of students for first 2-3 months and this period is more crucial as it can give the feeling of protected Institution. However, the surveillance in the Institution and Anti Ragging Squads are prevalent, all the Deans, HoDs, Faculty and Physical Directors are also requested to be more vigilant throughout the day until the student departed from the Institution as prevention is better than cure. In this regard mentoring is very important and for every 20 students one mentor will be allotted who will observe the student and he/she will be responsible to bring to the notice of the Committee. The Local Police Inspector also visits our campus soon and will address separately students to bring awareness and consequences among them. The Director said that this academic year our Institution has good response and better admissions and most of the seats under Convenor and Management quota were filled. There are 11 Sections in 1st Year and there may be 65 students in each class. The quality we are adding every year resulted good quality of admissions. Hence, our responsibility increased and requested try to get good results from the day one. We should be very careful towards 1st year students and they should not feel unhappy in the campus. The attitude of the Faculty and friendly atmosphere in the College is very important. The Deans and HoDs are requested to propagate the importance of the attitude on campus and off campus so that the information passes to juniors which help in future admissions, for this we have to maintain Academic standards and to maintain Every one of us should work hard in this direction and we can also adopt discipline. corporate methodology and prepare students well and good performance in the examinations and our ultimate goal is to get 100% result and above 7 grade. The two weeks Induction programme will be conducted to the 1st year students as per AICTE instructions and Academic Calendar. The Induction programme must be planned perfectly, but not for name

sake. He further said that generally the students behavior in Intermediate stage is some thing different and some time ferocious. We bring to change their attitude to have good carreer and we need to train the students of general behavior, regularity in attending classes, punctuality. The students admitted in the campus, 10-15 days are very crucial to make the students soft. There should be no arguments with the students and avoid using harsh words. In the present A.Y, the students strength in the campus is more than 3000. The Director further informed that Anti Ragging Committee has been constituted to bring awareness among the students about the consequences of ragging and take measures to prevent the ragging in and outside the Campus. Further Anti Ragging Squad also been constituted in and around the College campus with the faculty and staff of the College to take suitable measures to curb the ragging menace and to augur well in preventing/quelling ragging and if any uncalled for behavior/incident by the students.

The Director further informed that drug culture is increasing in Higher Educational Institutions and giving alarm very vigilant about the increasing drug culture. Drug culture is spoiling the society. Anti Ragging Committee will also act as Antidrug Committee to prevent youth from using illicit drugs by enhancing their awareness and understanding of the harmful social and health effects of illicit drug use and to develop and implement community-based interventions and initiations to prevent illicit drug use. Also informed an Anti-Drug Committee is constituted in the Institution to take care of illicit drug use.

The Director further requested the members to bring awareness among the students about the consequences of ragging and to take measures to prevent the ragging in and outside the campus. He has further requested the Transport in-charge that in the buses 1<sup>st</sup> year students should be allotted seats in first, second and third rows and next faculty should be given the seats. After faculty, the other years students should be accommodated and bus incharge should see that no indisciplinary actions happens when students are travelling in the

buses and if necessary allot seat numbers also to the students. The faculty coming by own vehicles also should be vigilant at Rana Bakery, Narapally X Roads. Further the students committees will be formed and meeting will be conducted with them to explain guidelines of Anti ragging and consequences of ragging. First three months are very important to the students accustomed to our procedure/culture. The role of the Physical Directors also very important and requested them to observe meticulously to prevent any kind of such event and settle on the spot. He further informed that some times small issue may become big issue. He has requested all the members of the Squad to keep strict vigilance and bring the incidents, if any, to the notice of the Convener or Director for taking necessary action to make our campus as "RAGGING FREE CAMPUS".

The Director thanked all the members and concluded the meeting at 3.30 PM.
