The School of Management Sciences, NNRG Integrated Campus, organized a Legal Awareness Session in association with Naveen Investment India Pvt Ltd, with the objective of enhancing legal literacy among management students. The programme aimed to familiarize students with fundamental aspects of Civil, Criminal, Constitutional, and Corporate Business Laws relevant to both personal and professional life.

The session commenced with an introductory address by Dr.T.Ravindra Reddy -Dean, School of Management Sciences, who emphasized the importance of legal awareness for future managers

and entrepreneurs. The Dean highlighted how a basic understanding of law helps in ethical decision-making, corporate governance, and compliance in business organizations.

The Dean formally welcomed the distinguished resource person **Mr. Nallapu Manideep**, Advocate, High Court of Telangana. The Dean expressed gratitude to the guest for accepting the invitation and sharing his valuable time and expertise with the students and faculty members.

Objectives of the Program:

- To create awareness about basic legal rights and duties.
- To explain the relevance of civil and criminal laws in day-to-day life.
- To provide an overview of constitutional provisions affecting citizens and businesses.
- To introduce essential concepts of corporate and business laws applicable to management professionals.

Summary of the Session:

During the session, Mr. Manideep delivered an insightful and interactive lecture that was both informative and application-oriented. He elaborated on the following areas with practical examples drawn from real-life situations and court experiences:

- **Civil Laws:** Mr. Manideep explained the importance of contracts in everyday and business transactions. He discussed valid contracts, breach of contract, and remedies available to aggrieved parties, citing examples such as non-fulfilment of service agreements and property sale disputes. He also highlighted common property-related issues like title verification and documentation. In addition, consumer protection laws were explained with examples of defective products, unfair trade practices, and the role of consumer courts in safeguarding consumer rights.
- **Criminal Laws:** The resource person provided clarity on the nature of criminal offences, distinguishing between cognizable and non-cognizable offences with simple illustrations. He explained legal procedures such as filing an FIR, investigation, and trial process. Preventive measures were emphasized by discussing cyber-crimes, frauds, and personal safety, encouraging students to be legally aware and cautious in both digital and physical environments.
- **Constitutional Laws:** Mr. Manideep elaborated on the significance of the Constitution as the supreme law of the land. He explained fundamental rights such as equality, freedom of speech, and right to life with relatable examples. Fundamental duties were also discussed, stressing responsible citizenship. He highlighted how constitutional provisions influence governance, public administration, and the protection of individual rights.
- **Corporate Business Laws:** Focusing on management students, the speaker explained company formation procedures, types of companies, and the legal requirements involved. He discussed the roles and responsibilities of directors, corporate governance standards, and statutory compliance under company law. Real-life corporate cases were referenced to explain legal implications of non-compliance, emphasizing the need for ethical and lawful business practices in organizations.

The resource person enriched the session with real-time examples, case references, and practical insights from his experience as an advocate. Students actively participated by raising questions related to corporate disputes, legal compliance, and individual rights.

The CEO of Naveen Investment India Pvt Ltd Mr. D. Naveen addressed the students highlighting the importance of legal acts to the customers like consumer protection act etc in the daily life of their purchase and sales of the products and services. He also explained with one example of LG washing machine .

Learning Outcomes

At the end of the session, students were able to:

- Understand the basic structure and application of civil, criminal, and constitutional laws.
- Recognize the importance of legal compliance in business and corporate management.
- Develop awareness of their rights and responsibilities as citizens and professionals.
- Apply legal knowledge in managerial decision-making and ethical practices.

Valedictory Address




Conclusion


