• The School of Management Sciences, NNRG conducted a webinar on "Personal Finance Management & IPO and Importance of Due Diligence in Investing" on 14<sup>th</sup> June, 2023 in association with Institute Innovation Council and in collaboration with IDCL, Investor Protection Trust, Hyderabad. Mr. Narasinga Rao, SEBI registered Senior Research Analyst & Portfolio Counsellor, Sampadha, Hyderabad was invited to be the Guest speaker. At the outset. Dr. T. Ravindra Reddy, Dean, School of Management Sciences welcomed the Guest and introduced to all faculty members and students of NNRG. Dean explained about the importance of small investments for future requirements to the students for their higher education etc. How to manage family income for future uncertainties. He explained about income, spending, investment and protection. He described the importance of awareness programmes regarding stock market investments and how to remove financial illness, how to convert traditional investments into modern investments which results in good returns and also increased level of production and productivity to the Nation. He also described about importance of inflation and its impact on investments.

Mr.Narasinga Rao, Guest speaker as a part of his lecture elevated some of the important aspects such as various elements related to personal finance management and importance of investments, Importance of Dmat accounts and how to operate the transactions with other sources— right kind of investment at right age and right time, facing of risk involved in investments. He shared his knowledge about financial markets, mutual funds, money markets and capital markets, Equity markets and Insurance, electronic format of investments, safe digital transactions, fundamental analysis, technical analysis and derivative analysis.
