#### **Highlights**



- **Second-Year Students:** Discussions centered on the progress made since the first year and the importance of maintaining a balance between academics and personal life. Sixteen parents participated actively in this session.
- **Third-Year Students:** For the eight parents who attended, the focus was on preparing for final year challenges, including internships, projects, and future career plans. Emphasis was placed on professional development and readiness for the job market.

#### **Feedback and Action Points**

- **Positive Feedback:** Parents appreciated the detailed academic reports and the open communication with faculty.
- Concerns: Some parents raised concerns about the workload and stress levels of students. Others highlighted the need for more interactive and engaging teaching methods.
