Consolidated Report and Outcome of the Activity

The institute organized one day internal hackathon for SMART INDIA HACKATHON(SIH) 2025 on 25-09-2025. Mr Sai Pavan Devulapalli, Managing Director and CEO of DYIS Private Limited, is invited as Chief Guest for evaluating student ideas for the problem statements defined in the SIH2025 portal. Dr. K. Srinivas Babu, Dr S Sreehari Raju and Mr. B. Durga Prasad were empanelled in jury.

Dr C V Krishna Reddy, director NNRESGI also explained the importance of such events and encouraged the students to participate in more events to enhance logical programming, design and testing skills of the students enormously. Mr. A Naveen, the Single Point of Contact (SPOC) for the college, provided an overview of the Smart India Hackathon (SIH). He discussed its significance and goals, as well as the rules and regulations governing the competition. Dr. K. Rameshwaraiah, Head of the Computer Science and Engineering (CSE) department, encouraged students to take part in hackathons to foster their technical abilities. The Judge, Mr Sai Pavan Devulapalli motivated the students to improve their problem solving skills by learning how to develop applications to solve real world problems and to address the current needs of the stake holders in the domains mentioned from time to time which in turn enhance entrepreneurship skills. Dr G Janardhana Raju, Dean School of Engineering and IIC Convener addressed the importance of such kind of technical events which were being conducted nationwide by public sector bodies like MHRD, AICTE with financial assistance also. Hence there is an urgent need of student attention towards such events.

Total 33 teams (198 students, 111 male and 87 female) have participated in this event. As per the guidelines of Smart India Hackathon – 2025, and to encourage female participation in innovative problems, each team consists of at least one female student as a member. Out of them, 29 teams with software problems and 4 teams with hardware problems were chosen by the participants to work upon.

Evaluation Criteria:

1. Clarity and Details in the Prescribed Format (Problem Understanding):

 Assessment Focus: How well the team understands and articulates the problem they are addressing. This includes the clarity and completeness of the information presented in their submission.

2. Novelty of the Idea:

Assessment Focus: The originality and innovation of the idea. This criterion
evaluates whether the solution is new or offers a unique approach compared to
existing solutions.

3. Feasibility:

Assessment Focus: The practicality of the solution. This includes assessing
whether the proposed solution can be realistically implemented with the
available resources and within a feasible timeframe.

4. Sustainability:

 Assessment Focus: The long-term viability of the solution. This criterion examines whether the solution can be maintained and scaled over time, and if it has a lasting impact.

5. Potential for Future Work Progression:

 Assessment Focus: The scope for further development and expansion of the solution. This includes evaluating whether the project has potential for future enhancements or applications.

The jury used these criteria to ensure a comprehensive and objective evaluation of each team's problem, focusing on various aspects from problem understanding and idea novelty to feasibility and presentation skills. At the end, Judges and Jury Members discussed and selected 10 teams from the total pool of participants.
