It promotes understanding of Intellectual Property Rights (IPR) and supports the development of new business relationships and start-ups.

#### • Establish an innovation portal:

An IIC creates an online platform to showcase innovative projects by faculty and students and to serve as a central point for information.

#### • Network and collaborate:

The IIC collaborates with industry, alumni networks, and other national entrepreneurship development organizations to strengthen the local innovation ecosystem.
