### **Objectives:**

3. The Committee oversees the function of the Examination Department, including communication with candidates, the logistics of preparing for examinations and communications with overseas centers.
4. The Coordinator of the Examination and the Committee, from time to time, responsible for providing advice to the Principal on matters pertaining to examinations.
5. Provide information about the results, grades, rewards and awards won by the college pertaining to academic achievements to the Public Relation, Press, Electronic Media Committee.

**Frequency of Meeting:** The frequency of committee shall meet once in every week preferably on Thursday. In addition any extraordinary meeting will be conducted in the event of exigency.
